GENERAL PRICE LIST: Effective April 23, 2019 (Note: Prices are subject to change without prior notice.)

Direct cremation is a disposition of human remains by cremation without formal viewing, visitation or ceremony with the body present.
FTC required disclosures: The goods and services shown below are those we can provide to our customers. You may choose only the items you desire, however, any cremation arrangements you select will include a charge for our basic services. If legal or other requirements mean you may buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the cremation goods and services you selected.

BASIC PROFESSIONAL SERVICE.....\$350.00

Includes: 24-Hour availability of staff for emergency service, Conference with family, Preparation and delivery of official forms including, death certificate, cremation approval and notification of death to the Social Security Administration, Filing of original death certificate with The Public Health Unit, Obtaining certified copies of death certificates for family.

REMOVAL AND TRANSPORTATION TO CREMATORY.....\$150.00

Includes removal of the deceased from place of death within a 50 mile radius of A Direct Cremations or The Villages and transport to Crematory by one removal staff. (Any mileage over 50 miles will be charged at \$3.00 a loaded mile.)

ALTERNATIVE CREMATION CONTAINER.....\$25.00

Caskets are not required for direct cremations. (A container to encase the body is required by law.) You may use an alternative container for direct cremation. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (With or without outside coverings.) The containers we use are fiberboard. You, the purchaser, have the option of providing a cremation container and deleting this price from our regular charges.

REFRIGERATION: (ALTERNATIVE TO EMBALMING).....\$20.00

Embalming is not required for direct cremations.

CREMATION.....\$250.00

TOTAL ITEMIZED PRICE FOR THESE SERVICES.....\$795.00

No cremation urn is included with any of the above described services or items. You may provide your own cremation container or purchase one from A Direct Cremations. If you provide a cremation urn, the interior space of the container must be at least 200 cubic inches.

The Federal Trade Commission requires the disclosure of costs of each individual funeral item and service offered. You are entitled to complete information via telephone, mail or personal inquiry. Under these regulations, those who offer Direct Cremations must tell you that Florida State Law does not require embalming, or the use of a casket for direct cremations.
